1.	Welcome & introductions	Action by:
	Members registered their attendance / introduced themselves via the chat screen.	
2.	Confirmation of agenda	
	The agenda was adopted as circulated.	
3.	Previous minutes	
	Previous minutes were accepted by general consent.	
4.	Status of action items	
	 Parent/school notifications Project representatives have shared materials with SD #6 to inform parents of work underway and the need to be seen and be safe on Hwys 93/95. 	Jack
5.	Project update and discussion	
	 Summary of construction activity (Jack/Chris Koop/Nikky Turner) Jack shared recent footage of the project site provided by KHCC, with Chris Koop providing an overview description of the major elements being constructed. Chris and Nikki Turner shared further info/commentary on recent construction photos. Commentary highlights included: The future eastbound lanes through most of the project will be in use 	
	 by early December. Cut 3 - pretty much down to grade level. Blackwall bridge - girders placed, deck panels being installed. Only future eastbound lanes to be put into service in December. Caribou Wall is supported and stabilized with 248 piles in Caribou Wall, with another 48 for the Caribou Viaduct - nearly 300 in total in 	

	this section The first four bridges and viaducts from west to east combined are over 1 km. Traffic management - stoppages and closures (Fall 2022 extended closure) BC government info bulletin released Sept. 13. Closure begins noon Sept. 26 until noon Oct. 7 - open until noon Oct. 11 - closed until 6 a.m. Dec. 1; not reopening for Sept. 30 or Nov. 11 weekends. May be another extended closure next spring - no exact dates at this time. Pass system has been reactivated. Hilary Barnett noted that, in addition to increased enforcement and other measures applied in past closures, preparations on the alternative route have included wider mowing swaths to improve the visibility of wildlife, shoulder widening in some key locations to help with highway access and egress, and refreshed line painting.	
6.	 Round Table: issues, opportunities, considerations It was noted that day passes might not always provide for a round trip through the canyon, as capacity and urgency are factors considered in giving passage through the construction zone in either direction. Parks Canada will be sending out messages about winter road safety. People using emergency phones on Highway 93 are directly routed to dispatch, who may transfer the call to 911, but the transfer can take up to 5 minutes. 	
7.	 Next steps / next meeting The group agreed to target February 2023 for the next meeting, with it being suggested that members be polled to help select the most convenient date/time.
